GENERAL CONDITIONS – PLEASE READ CAREFULY AND SIGN

Enrolment: Places are limited. Registration will be only considered in order of arrival (registration form + acceptance + confirmation + payment (deposit)) until the maximum number of participants is reached.

Full Board option: This option includes overnight stays in single rooms, breakfasts, lunches & dinners from Monday 21st July to Monday 5th August. Security Personnel, "Chaperon" at dorms, wi-fi, spacious bathroom, entertainment.

Arrivals: Students can only arrive from Sunday 21st July from 12 pm. Dorm doors are closed before 12 pm. Book your flight in accordance with this check-in time. For Students arriving at the dorm on Sunday 21st July, dinner (only) will be provided at 7 pm.

Non-Residential check-in: 8 am on Monday 22nd July 2024 at BIB

Lost Keys: 25 € cash will be charged if dorm keys are lost.

Bedding: 45 € will be asked in cash upon arrival for the dorms package (pillows, duvet, sheets). This is mandatory for those selected the full-board option.

Departure: Students must leave the dorm from Sunday 4th August from 8 pm, or Monday 5th August no later than 10 am. Dorm doors will close at 10 am on Monday 5th August. Book your flight departure in accordance with this check-out time. Only breakfast will be provided for students leaving the dorm on Monday 5th August.

Lunches: Meals not consumed during the stay will not be refunded.

Classes: The Brussels International Ballet Direction will form groups based on participant's age and level. The BIB direction is responsible for this decision, and it is indisputable. The first day of the Summer Intensive Program allows the finalization of the different group levels. The final plan of the courses will be given to all students on the first day and will be communicated to the Facebook Private Group. Note for Group 1: all students of Group 1 will have 1 contemporary course. This is indisputable. This is not applied for Group 2 which will participate in 2 different contemporary classes.

Compulsory health insurance

The Summer Intensive program requires parents to submit their child's insurance policies and health plan. Students must be fully covered in case of accidents or damages they may cause during their stay. The school requires the attestation before the Summer Program starts. The organizers are not responsible for any injuries or material damage caused or suffered by anyone during the course.

The participant agrees to indemnify Brussels International Ballet against any injuries or damage to persons, loss of life or loss or theft of property, whether caused by negligence or otherwise while participating the activities provided throughout the program and associated activities from registration.

Payment Conditions

Once you receive the acceptance letter, you must pay 60% of your total sum to secure your placement in the program. Your place in the program will be reserved for you, therefore this deposit is non-refundable.
